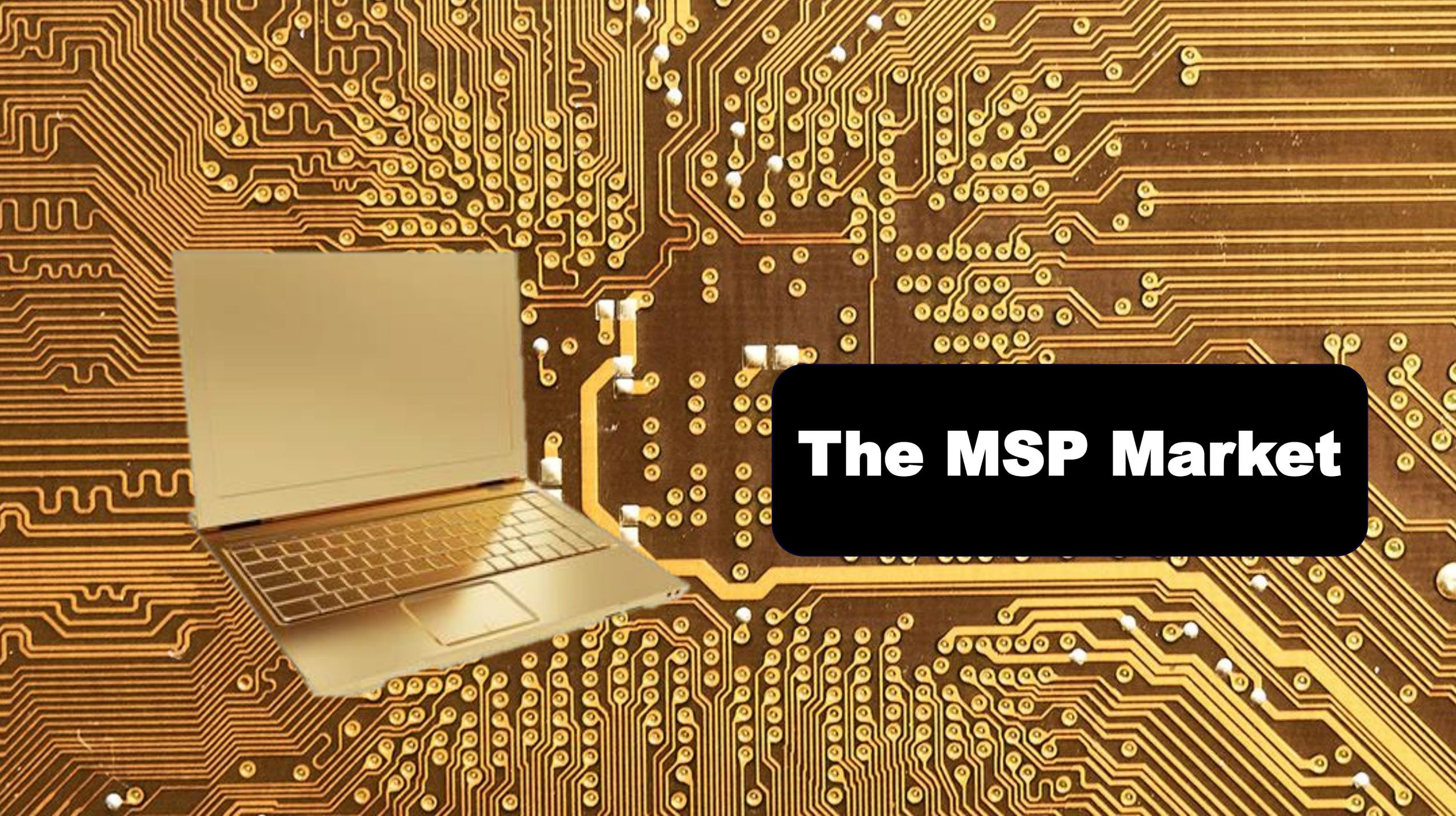

# The MSP Market

# The market opportunity for MSPs

The managed service provider (MSP) market is booming, with estimates it will grow from its current size of nearly £276 billion per year to more than £372 per year billion by 2028

Billion Reference points:

\$1,000,000,000 (1000 x of a million)

McDonald's Revenue in 2023 – \$25.49B

1 Million seconds = about 12 days

1 Billion seconds = about 32 years

*IT spending to spike 8% in 2028 as Gen AI drives growth – Gartner*

*Managed IT services will see a compound annual growth rate of 8.1% through to 2026*

*Cloud based managed services are expected to grow at 15.4 % through to 2026*

# Benefits of Offering Compliance Services

## **Increased revenue opportunities:**

Compliance services are a growing market. MSPs that offer these services will be well-positioned to capitalise on this momentum and generate more recurring revenue.

## **Margin expansion:**

Cybersecurity and compliance services generally have higher margins than traditional IT-based MSP services. They're also, due to their nature, typically recurring.

## **Client retention:**

More service offerings lead to happy clients who are more likely to expand existing relationships with an MSP.

## **Brand enhancement:**

As a trusted provider of compliance services, MSPs can enhance their reputation, increase brand awareness, and attract new clients.
